Background Information: Temporary on-sale liquor licenses for the annual street dance sponsored by the Park Days Committee were approved and issued to Bar X Bar, Fajita's Bar and Grill, Fat Boys Bar, and Wind Street Station. The temporary licenses allow the consumption of alcoholic beverages outside of the liquor establishments on Wind Street between Pipestone and 2nd Avenues on July 5th, 2019 from 6:00 PM to 1:30 AM. The Zandt building has since deteriorated even more and additional blocks are falling requiring that the street dance be relocated to 2nd Avenue between Wind and Center Streets. The previously issued liquor licenses will need to be amended to state the new location.
