**COUNCIL PROCEEDINGS
June 19th, 2020**

The City Council of the City of Flandreau, South Dakota, met in special session on Friday, June 19th, 2020 at 4:00 p.m. via Zoom conference.

Present: Mayor Mark Bonrud. Aldermen: Brad Bjerke, Bob Pesall, Dan Sutton, Karen Tufty, and Jason Unger. Absent: Donald Whitman. Also present were City Administrator Jeff Pederson; and Finance Officer Karen Gundvaldson.

The proposed agenda was reviewed. Motion by Tufty and seconded by Sutton to adopt the proposed agenda. The following members voted aye: Bjerke, Pesall, Sutton, Tufty, and Unger. Nays: None. Absent: Whitman. Motion carried.

Motion by Bjerke and seconded by Tufty to authorize Bar X Bar, Fajita's Bar and Grill, and Fat Boys Bar to close Wind Street between Pipestone and 2nd Avenues to hold a street dance on July 3rd, 2020 from 5:00 PM to 1:30 AM. The following members voted aye: Bjerke, Pesall, Sutton, and Tufty. Nays: Unger. Absent: Whitman. Motion carried.

Motion by Pesall and seconded by Sutton to approve a temporary liquor license for Bar X Bar for a street dance on Wind Street between Pipestone and 2nd Avenues on July 3rd, 2020. The following members voted aye: Bjerke, Pesall, Sutton, Tufty, and Unger. Nays: None. Absent: Whitman. Motion carried.

Motion by Pesall and seconded by Unger to approve a temporary liquor license for Fajita's Bar and Grill for a street dance on Wind Street between Pipestone and 2nd Avenues on July 3rd, 2020. The following members voted aye: Bjerke, Pesall, Sutton, Tufty, and Unger. Nays: None. Absent: Whitman. Motion carried.

Motion by Sutton and seconded by Bjerke to approve a temporary liquor license for Fat Boys Bar for a street dance on Wind Street between Pipestone and 2nd Avenues on July 3rd, 2020. The following members voted aye: Bjerke, Pesall, Sutton, Tufty, and Unger. Nays: None. Absent: Whitman. Motion carried.

Council Comments: Alderman Pesall shared with Council that the lumber located by the Zandt building has been picked up. City Administrator Pederson indicated City Attorney Bruning is researching whether or not the balance remaining in the escrow account for repairs can be accessed to replace the deteriorated sidewalk around the building.
